




Fig 1 – General Specifications and Service Bay Layout

# VERTICAL CLEARANCE

Check the height of the area where the lift is to be installed. Clearance should be calculated based on the full raised height of the lift.



Failure by purchaser to provide adequate clearance could result

unsatisfactory lift performance, property damage, or personal injury.

# SAFETY NOTICES AND DECALS

For your safety, and the safety of others, read and understand all of the safety notices and decals included here.

READ **ENTIRE BEFORE** MANUAL ASSEMBLING, INSTALLING, OPERATING, OR SERVICING THIS EQUIPMENT.

PROPER **MAINTENANCE** AND INSPECTION IS NECESSARY FOR SAFE OPERATION.

### DO NOT OPERATE A DAMAGED LIFT.

Safety decals similar to those shown here are found on a properly installed lift. Be sure that all safety decals have been correctly installed on the Power Unit reservoir. Verify that all authorized operators know the location of these decals and fully understand their meaning. Replace worn,

faded, or damaged decals promptly.

**WARNING** 

Do not attempt to raise a vehicle on the lift until the

lift has been correctly installed and adjusted as described in this manual.




The load applied to each rolling jack should not exceed ½ of the total capacity of the runways.

# SAFETY WARNING LABELS FOR INGROUND LIFTS

Lift Owner/User Responsibilities:

- A. This Safety Warning placard SHALL be displayed in a conspicuous location in the lift area.
- B. Use one of the mounting arrangements illustrated on back of this placard.
- C. These Safety Warning labels supplement other documents supplied with the lift.
  D. Be certain all lift operators read and understand these labels, operating instructions and other safety related information supplied with the lift.





### RECEIVING

The shipment should be thoroughly inspected as soon as it is received. The signed bill of lading is acknowledgement by the carrier of receipt in good condition of shipment covered by our invoice.

If any of the goods called for on this bill of lading are shorted or damaged, do not accept them until the carrier makes a notation on the freight bill of the shorted or damaged goods. Do this for your own protection.

NOTIFY *Challenger Lifts* AT ONCE if any hidden loss or damage is discovered after receipt.

IT IS DIFFICULT TO COLLECT FOR LOSS OR DAMAGE AFTER YOU HAVE GIVEN THE CARRIER A CLEAR RECEIPT.

File your claim with *Challenger Lifts* promptly. Support your claim with copies of the bill of lading, freight bill, and photographs, if available.




Fig 2 - Package Components

# INSTALLATION

# SAFETY REQUIREMENTS FOR INSTALLATION AND SERVICE

Refer to ANSI/ALI ALIS (current edition)

**IMPORTANT:** Always wear safety glasses while installing lift.

# **TOOLS (MINIMUM REQUIRED)**

- a. Tape measure, 25ft
- b. 10" & 12" adjustable wrench
- c. Standard open-end wrenches 3/8", 7/16", 1/2", 9/16", 5/8", (2) 11/16", 3/4", 15/16"
- d. Box knife
- e. Needle nose pliers
- f. Torque wrench: 120-foot pounds minimum with 1 5/16" socket

# **Assembly**

- 1. Loosely install the runways to the lift plungers with 7/8-9 x 7 bolts, see Fig. 1. (The front end of the runway measures 84 5/8" from the center of the plunger to the front edge of the runway shell compared to 89 5/8" for the rear.) The diagonal cross straps on the bottom of the runway should be located toward the front of the lift.
- 2. Attach Rear Cross Tube using the ½-13 Flange head bolts.
- 3. Check to ensure the runways are parallel to one another (Diagonals within ½") and torque the 7/8-9 x 7 bolts from step one to 120 ft-lbs.
- 4. Assemble the approach ramps to the closed end with the ramp hinge pins and cotter keys.
- 5. Assemble the front stops and end tubes to the front side of the runways using the ½-13 Flange Head bolts.
- 6. Raise the lift and assemble the adjustment feet. There are 4 feet across the open end and 2 on the outside of the closed end.
- 7. Lower the unit completely, level the runways with the adjustment screws, and lock the adjustment screws in place using the 1 3/8-6 Jam nuts.

Do not remove or deface these warning labels or allow them to be removed or defaced. For your safety, and the safety of others, read and understand all of the safety notices and decals included.

### **Owner/Employer Responsibilities**

This lift has been designed and constructed according to ANSI/ALI ALCTV standard. The standard applies to lift manufacturers, as well as to owners and employers. The owner/employer's responsibilities as prescribed by ANSI/ALI ALOIM, are summarized below. For exact wording refer to the actual standard provided with this manual in the literature pack.

The Owner/Employer shall ensure that lift operators are qualified and that they are trained in the safe use and operation of the lift using the manufacturer's operating instructions; ALI/SM, ALI Lifting it Right safety manual; ALI/ST, ALI Safety Tips card; ANSI/ALI ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; ALI/WL Series, ALI Uniform Warning Label Decals/Placards; and in case of frame engaging lifts, ALI/LP-GUIDE, Vehicle Lifting Points/Quick Reference Guide for Frame Engaging Lifts.

The Owner/Employer shall establish procedures to periodically inspect the lift in accordance with the lift manufacturer's instructions or ANSI/ALI ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; and the employer shall ensure that the lift inspectors are

qualified and that they are adequately trained in the inspection of the lift.

The Owner/Employer shall establish procedures to periodically maintain the lift in accordance with the lift manufacturer's instructions or ANSI/ALIOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; and the employer shall insure that the lift maintenance personnel are qualified and that they are adequately trained in the maintenance of the lift.

**The Owner/Employer shall** maintain the periodic inspection and maintenance records recommended by the manufacturer or ANSI/ALI ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance.

The Owner/Employer shall display the lift manufacturer's operating instructions; ALI/SM, ALI Lifting it Right safety manual; ALI/ST, ALI Safety Tips card; ANSI/ALI ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; and in the case of frame engaging lift, ALI/LP-GUIDE, Vehicle Lifting Points/Quick Reference Guide for Frame Engaging Lifts; in a conspicuous location in the lift area convenient to the operator. Demonstrate the operation of the lift to the owner and review correct and safe lifting procedure, using the "Lifting It Right" booklet as a guide.

# IMPORTANT SAFETY INSTRUCTIONS

When using your garage equipment, basic safety precautions should always be followed, including the following:

- 1. Read all instructions.
- 2. Care must be taken as burns can occur from touching hot parts.
- 3. To reduce the risk of fire, do not operate equipment in the vicinity of open containers of flammable liquids (gasoline).
- 4. Keep hair, loose clothing, fingers, and all parts of body away from moving parts.
- 5. Use only as described in this manual. Use only manufacturer's recommended attachments.
- 6. ALWAYS WEAR SAFETY GLASSES. Everyday eyeglasses only have impact resistant lenses, they are not safety glasses.

# **SAVE THESE INSTRUCTIONS**

### LIFTING A VEHICLE

Drive vehicle onto lift. Set parking brake and/or use wheel chocks that are provided with lift.

When the vehicle has reached the desired working height, release the power pack button, and lower the vehicle until the lock is engaged. The vehicle should remain level when lock is engaged.

IMPORTANT, before walking under the lift ensure that the lock is properly engaged.

It is not safe to work under the vehicle unless the lock is engaged, and the vehicle is level.

### **LOWERING A VEHICLE**

Ensure that the area under the vehicle is clear of personnel and tools.

Raise the vehicle until the lock is free.

Disengage the lock by depressing the palm button and holding it.

Lower the vehicle by depressing the lowering valve handle. Watch lift to ensure that the lift is lowering evenly. Continue to lower the vehicle until the runways rest on the floor. It is important to fully lower the lift to release hydraulic pressure on the system.

### **Maintenance**

The following maintenance points are suggested as the basis of a preventive maintenance program. The actual maintenance program should be tailored to the installation. See ANSI/ALI ALOIM booklet for periodic inspection checklist and maintenance log sheet.

If lift stops short of full rise or chatters, check fluid level, vehicle position and bleed both cylinders per Installation Instructions.

Replace all Safety, Warning or Caution Labels if missing or damaged.

To avoid personal injury, permit only qualified personnel to perform maintenance on this equipment.

IMPORTANT! Failure to keep lift free of corrosive agents and solvents will lead to reduced service life, which could result in property damage and/or personal injury.

If any problems are encountered, contact your local service representative.


# **Daily**

- Drain Water from air supply to avoid contamination of lock release components.
- Check lock operation. The lock operation should be heard as lift is raised.
- Keep area around lift / containment assembly clean and free of dirt, sand, water, etc. to prevent scoring of the plunger.
- Remove excess grease and debris from plunger by wiping them down with a clean cloth.

# Monthly

- Check fluid level in the power unit.
- Check for proper torque on all superstructure bolts (120 ft-lbs.).
- Grease Lift Guide bearings using Mobil 1 SCH1500 synthetic grease. Each guide bearing is supplied with a grease zerk and should take 10-12 pumps (hand pump only) while raising and lowering the lift empty.
