




Fig. 1A General Surface Mount Layout




Fig. 1B - General Flush Mount Layout




Fig. 2 - Flush Mount Pit Layout (Provided By Others)

Safety decals similar to those shown here are found on a properly installed lift. Be sure that all safety decals have been correctly installed on the lift. Verify that all authorized operators know the location of these decals and fully understand their meaning. Replace worn, faded, or damaged decals promptly.



Do not attempt to raise a vehicle on the lift until the lift has been correctly

installed and adjusted as described in this manual.


LOCATION

This lift has been evaluated for indoor use only with an operating ambient temp. range of 5 – 40°C (41– 104°F). Outdoor Installation is Prohibited.

Edition of Referenced Materials

Where any ANSI standard or ALI materials are referenced within this manual, the most recent edition shall apply.





SAFETY WARNING LABELS FOR HINGED FRAME ENGAGING LIFTS

Lift Owner/User Responsibilities:

- This Safety Warning placard
 SHALL be displayed in a
 conspicuous location in the lift area.
- B. Use one of the mounting arrangements illustrated on back of this placard.
- C. These Safety Warning labels supplement other documents supplied with the lift.
- Be certain all lift operators read and understand these labels, operating instructions and other safety related information supplied with the lift.



RECEIVING

The shipment should be thoroughly inspected as soon as it is received. The signed bill of lading is acknowledgement by the carrier of receipt in good condition of shipment covered by our invoice. If any of the goods called for on this bill of lading are shorted or damaged, do not accept them until the carrier makes a notation on the freight bill of the shorted or damaged goods. Do this for your own protection.

NOTIFY **Challenger Lifts** AT ONCE if any hidden loss or damage is discovered after receipt

IT IS DIFFICULT TO COLLECT FOR LOSS OR DAMAGE AFTER YOU HAVE GIVEN THE CARRIER A CLEAR RECEIPT.

File your claim with **Challenger Lifts** promptly. Support your claim with copies of the bill of lading, freight bill, and photographs, if available.

Flooring

Be certain you have the proper concrete floor to properly handle the loaded lift. Floor should be in generally good condition with no large cracks, spalling or deterioration.

Minimum requirements for concrete are 4 inches minimum depth, with steel reinforcement, 3500 psi, cured for 28 days per local commercial practice. Floor should be level within 3/8 inch over the installation area. No anchors should be installed within 8 inches of any crack, edge, or expansion joint.

If these conditions cannot be met, pads can be poured to accommodate the lift. Pad must be a minimum of 8 ft x 8 ft x 1 ft minimum thickness, 3500 psi steel reinforced mechanically attached to existing floor.

Check with local building inspectors and/or permits office for any special instructions or approvals required for your installation.

A qualified person should be consulted to address seismic loads and other local or state requirements.



Failure by purchaser to provide the recommended mounting surface could

result in unsatisfactory lift performance, property damage, or personal injury.

Vertical Clearance

Check the height of the area where the lift is to be installed. Clearance should be calculated based on the full raised height of the lift plus the height of the tallest vehicle you intend to service.



Failure by purchaser to provide adequate clearance could result in unsatisfactory

lift performance, property damage, or personal injury.

Electrical Requirements

For lift installation and operation, it is necessary to have a dedicated 115V single-phase 60-cycle circuit with a 20-amp circuit breaker or time delay fuse.

Tools Required for Installation

- 1. Concrete hammer drill.
- 2. 3/4 inch & 1/2-inch solid drill bit with carbide tip to ANSI Standard B94.12-1977.
- 3. Wrenches: 7/16, 1/2, 9/16, 5/8, 11/16, 15/16, 1 1/8 inch
- 4. Ratchet drive with the following sockets: 7/16, 1/2, 9/16, 1 1/8 inch
- 5. Hammer
- 6. Funnel
- 7. Torque wrench: 50-to-250-foot pounds
- 8. Adjustable wrenches: 8 and 12 inch

General Anchor Bolt Instructions

- 1. The anchor bolts must be installed at least 8 inches from any crack, edge, or expansion ioint.
- 2. Use a concrete hammer drill with a 3/4-inch carbide tip. Tip diameter to ANSI Standard B212.15 (.775 to .787).
- 3. Do not use excessively worn bits or bits which have been incorrectly sharpened.
- 4. Keep the drill in a perpendicular line while drilling.
- 5. Let the drill do the work. Do not apply excessive pressure.
- 6. Lift the drill up and down to remove dust and reduce binding.
- 7. Drill the hole through the floor or to a depth of 5 inches minimum. Drill completely through floor is possible.
- Vacuum the dust from the hole. This increases the holding power of the anchor holts
- 9. Insert the assembled anchor bolt into the
- 10. Tighten the bolt securely, and torque to 150 foot-pounds after installation is complete.

NOTE: Anchor bolt holes are designed for a tight fit. Using the lift frame, as a template will slightly enlarge the holes, allowing for proper tolerances once the anchor bolt is installed.

Installation

SAFETY REQUIREMENTS FOR INSTALLATION AND SERVICE

Refer to ANSI/ALI ALIS (current edition)

 Locate the pad lift on a level concrete floor with adequate space on all sides. Minimum floor thickness is 4". Minimum floor strength is 3500 psi.

WARNING DO NOT install on asphalt or other similar unstable surface.

NOTE: The pad lift is to be installed with the cylinder end pointing towards the rear of bay. **Be aware of pad lift clearances.**




Fig. 3 Rearward Movement Installation (Surface Mount)

NOTE: At full rise, the lift will move the vehicle rearward 13 1/4" as shown in Fig. 3.

2. Place lift and ramps in desired location. The ramp should be located to allow a minimum 1/2" clearance around the lift platform, See **Fig.1A**.

Installation (Flush Mount)

- Before placing lift in pit, insert the lock release rod thru the pivot block welded to the base of the lift. Once lift is in pit, this rod will not be able to be installed due to its overall length.
- Locate the pad lift in pit with adequate space on all sides.
- 5. Place front platforms in the pit with adequate space between the edge of the lift. Do not drill anchor holes until lift can be fully raised and lowered to ensure there are no interferences.




Fig. 4 Flush Mount Installation

Power Unit

CAUTION If lift is to be used in a paint booth, the electrical power unit **MUST** be mounted outside the booth.




Fig. 5 Power Unit Location

6. Place Power Unit Stand as shown in Fig. 5 for surface mount or flush mount applications. Operator should be in a position to notice any misalignment of lifting pads or vehicle during operation. Challenger Lifts does not recommend placing the Power Unit in a different location or orientation and doing so would be the responsibility of the installer and/or end user.

<u>IMPORTANT:</u> Power Unit Controls should always be orientated so operator is facing the direction of the lift when operating the lift

- 7. Anchor the power unit stand using concrete anchors provided. Mount the power unit to the stand with 5/16" hardware provided. (The power unit may also be mounted on a wall with the motor at a minimum of 18" above the floor. Purchase the appropriate mounting hardware to match the wall construction.)
- 8. Connect the end of the hydraulic hose with the 90-degree elbow to the pressure port on the power unit. Tighten securely to prevent leaking.

NOTE: To avoid damage to the hose, never run the hose under the lift or in the path of the automobile tires.

- Fill the reservoir with 6 quarts clean 10wt anti-foam, anti-rust hydraulic oil or Dexron III ATF. DO NOT USE OILS WITH DETERGENTS.
- 10. Place the open end of the hose into a clean bucket.

- 11. Electrical connection:
 - a.115V (standard wiring) Plug power unit cord into a dedicated 115V single phase 60 cycle circuit with a <u>20-amp circuit</u> <u>breaker</u> or time delay fuse.
 - b.230V (non-standard wiring) Connect Power Unit to suitable electrical source as shown in Fig 7.
- 12. For *Flush Mount only*, Route the Power Unit hose through the chase. Notice the tee connection is in front of the cylinders.
- 13. For Surface Mount only, Route the Power Unit hose along the expected path, into the holes in the Drive Side Ramp. Notice the tee connection is made in the center of the lift rearward of the cylinders.
- 14. Cycle the power unit (2 seconds on, 2 seconds off) until the hose expels a steady stream of fluid.
- 15. Connect the hose to the tee fitting on the lift.

Anchoring

16. There are (6) 13/16" diameter holes provided in the base frame for use with 3/4" anchor bolts. Once proper lift placement is complete, use a concrete hammer drill with a 3/4-inch carbide bit. Tip diameter should conform to ANSI Standard B212.15 (.775 to .787). Do not use excessively worn bits or bits which have been incorrectly sharpened. A core bit may be necessary if an obstruction is encountered. Never substitute with shorter anchor. Insert anchor bolts into holes but do not tighten yet.

Shimming

- 17. The pad lift frame must not be twisted, bent or otherwise misaligned by uneven floors when anchoring. This will cause damage to the lift. Maximum out-of-level is 1/4" between all anchor points. If this is exceeded, it must be shimmed at that anchor point. If shimming exceeds 1/4" at any location, the surrounding area under the base must be grouted to eliminate improper loading of the base.
- 18. Once all shims are in place, tighten all 3/4" anchor bolts to 150 foot-pounds and all 1/2" anchor bolts to 50 foot-pounds.
- 19. Using the Power Unit raise the lift looking for leaks and understanding air will be bleeding from the system.

Lock Release

- 20. Assemble lock release mechanism using roll pins, hardware, and components provided as shown in the figure below.




Fig. 6 Lock Release Bar (Some parts removed for clarity)

- 21. For *Flush Mount only*, slide lock rod support bracket over free end of lock rod before the handle is attached to the end, See *Fig. 6*. Install the handle using the Spring Pin. *Also*

- shown in Parts Breakdown at the end of this manual.
- 22. For **Surface Mount only**, make sure the Lock Release Rod Weld is routed through the Ramp. Install the Handle using the Spring Pin.

23. Ensure lock release functions properly and remains disengaged during complete lowering of the lift once the lock handle is rotated to the upright position. When lift is close to fully lowered, the lock release should reset automatically, and the handle should be in a horizontal position.

Additional Anchoring

- 24. For **Surface Mount only**, there are (8) 5/8" diameter holes in the ramp forms for use with ½" anchor bolts. Use the holes in the ramp forms as a template and drill holes. Insert anchor bolts into holes but do not tighten yet.
- 25. For **Surface Mount only with Cover Acc**, use the nine 20" hose covers and one corner cover to protect the hose in a desire path using Fig. 5. Drill Ø1/4" holes using the hose covers as a template and secure the covers to the floor with the provided 1/4" drive anchors
- 26. For *Flush Mount only*, ensure lock rod support bracket is shimmed as necessary for proper function of the lock release. Lock rod should pivot freely and be aligned with lock block near the center of the lift
- 27. For *Flush Mount only*, there are (8) 5/8" diameter holes in the front platforms and (2) 5/8" holes in the lock rod support bracket. Use the platforms as a template and drill holes and insert anchor bolts. Locate lock rod support bracket near lock rod handle and align with pivot block near center of lift base. Ensure bracket does not interfere with bottom of lift structure when lowered before drilling holes. Drill holes and insert anchor

bolts using bracket as a template. Do not tighten yet.

FINAL CHECKOUT PROCEDURE

- 28. Actuate the power unit to fully raise then fully lower the lift. Repeat 3 to 4 times.
- **CAUTION** The power unit operates at high pressure.
- 29. Raise and lower lift a few times and check hose and fittings for leaks and tighten if required. Check for binding, misalignment or damage. Correct any unusual condition before raising vehicle.
- 30. Demonstrate the operation of the lift to the owner/operator/employer using a typical vehicle and review correct and safe lifting procedures using the <u>Lifting It Right</u> booklet as a guide.
- 31. Return all provided literature (including this manual) to the literature pack envelope and deliver the envelope to the owner/operator/employer.
- 32. Complete the online warranty registration (refer to the included warranty statement).

OPERATION PROCEDURE

SAFETY NOTICES AND DECALS

This product is furnished with graphic safety warning labels, which are reproduced on page 3 of these instructions. Do not remove or deface these warning labels or allow them to be removed or defaced. For your safety, and the safety of others, read and understand all of the safety notices and decals included.

OWNER/EMPLOYER RESPONSIBILITIES

This lift has been designed and constructed according to ANSI/ALI ALCTV standard. The standard applies to lift manufactures, as well to owners and employers. The responsibilities owner/employer's as prescribed by ANSI/ALI ALOIM, are summarized below. For exact wording refer to the actual standard provided with this manual in the literature pack.

The Owner/Employer shall insure that the lift operators are qualified and that they are trained in the safe use and operation of the lift using the manufacturer's operating instructions; ALI/SM, ALI Lifting It Right Safety Manual; ALI/ST, ALI Safety Tips Card; ANSI/ALI ALOIM; American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; ALI/WL Series, ALI Uniform Warning Label Decals/Placards; and in case of frame engaging lifts, ALI/LP-GUIDE, Vehicle Lifting Points/Quick Reference Guide for Frame Engaging Lifts.

The Owner/Employer shall establish procedures to periodically inspect the lift in accordance with the lift manufacturer's instructions or ANSI/ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; and the employer shall insure that the lift inspectors are qualified, and they are adequately trained in the inspection of the lift.

The Owner/Employer shall establish procedures to periodically maintain the lift in accordance with the lift manufacturer's instructions or ANSI/ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; and the employer shall insure that the lift maintenance personnel are qualified, and they are adequately trained in the inspection of the lift.

The Owner/Employer shall maintain the periodic inspection and maintenance records recommended by the lift manufacturer or ANSI/ALOIM, American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance.

The Owner/Employer shall display the lift manufacturer's operating instructions; ALI/SM, ALI Lifting It Right Safety Manual; ALI/ST, ALI Safety Tips Card; ANSI/ALI ALOIM; American National Standard for Automotive Lifts-Safety Requirements for Operation, Inspection and Maintenance; and in case of frame engaging lift, ALI/LP-GUIDE, Vehicle Lifting Points/Quick Reference Guide for Frame Engaging Lifts; in a conspicuous location in the lift area convenient to the operator.

IMPORTANT SAFETY INSTRUCTIONS

When using your garage equipment, basic safety precautions should always be followed, including the following:

- 1. Read all instructions.
- 2. Care must be taken as burns can occur from touching hot parts.
- 3. To reduce the risk of fire, do not operate equipment in the vicinity of open containers of flammable liquids (gasoline).
- 4. Keep hair, loose clothing, fingers, and all parts of body away from moving parts.
- 5. Use only as described in this manual. Use only manufacturer's recommended attachments.
- ALWAYS WEAR SAFETY GLASSES. Everyday eyeglasses only have impact resistant lenses; they are not safety glasses.

Operating Instructions


NOTE: After reviewing these instructions and all decals, get familiar with lift controls by running the lift through a few cycles before loading vehicle on lift.

Loading Vehicle

- Be sure lift is fully lowered, and service bay is clear of all personnel before the vehicle is driven on to lift.
- 2. Position vehicle over lift having equal distance from front tire to end of front ramps and rear tire to end of rear ramps. Vehicle must also be centered side to side.

WARNING Lift is designed to raise complete vehicle. **NEVER** use to raise just one end or side of vehicle.




Fig. 7 Service Garage Lift Points

NOTE: Some vehicles may have manufacturer's recommended lift points identified by triangle shape marks located on its undercarriage. Also, there may be a label located on the right front door lock face showing specific vehicle lift points. If the vehicles lift points are not identified, refer to the service garage lift points shown in Fig. 7. ALWAYS follow the operating instructions supplied with the lift.

CAUTION Most specialty or modified vehicles cannot be raised on a frame engaging or pad lift. Contact vehicle manufacturer for raising or jacking details.

- Before lifting the vehicle be sure that:
 - A. Individual axle weight of vehicle does not exceed one-half lift capacity. See safety instructions (capacity).
 - B. Spacer pads are in secure contact with manufacturer's frame at vehicle recommended lift points.
 - C. Vehicle is stable on lift and neither front nor rear heavy.




Fig. 8 Optional Spacer Pads

 - D. Use optional 4 3/4" and 6 3/4" spacer pads if additional height between lift and vehicle is required to clear underbody parts as shown in Fig. 8.

CAUTION Always use minimum number of spacer pads to clear obstruction. Spacer pads should never be stacked more than (2) pads high in any combination.

CAUTION With some vehicles, the removal (or installation) of heavy components may cause a critical shift in balance and result in vehicle instability. Refer to the vehicle manufacturer's service manual for recommended procedures when performing these services.

Raising Vehicle

- 4. To raise lift:
 - A. Actuate RAISE switch on electric power unit.
 - B. Raise vehicle until tires clear floor.
 - C. Stop and check spacer pads for secure contact at manufacturer's recommended lift points.
 - D. Continue to raise to desired height ONLY if vehicle is secure on lift.
 - E. Once you have reached the required height set into lock by depressing the lowering handle.

Lowering Vehicle

5. To lower lift:

Stand clear of lift and vehicle when lowering. Observe pinch point warning decals.

- A. Remove all tools or other objects from lift area.
- B. Raise vehicle approximately 1".
- C. Disengage lock by rotating the lock release handle clockwise until it stops.
- D. Push **LOWERING** valve handle to lower lift.

CAUTION Lowering handle must be held down to continue to lower lift. DO NOT override self-closing lift controls.

6. Before moving vehicle, remove any spacer pads and be sure lift is at the fully lowered position.

LOSS OF POWER

If for any reason the lift will not raise off the locks or the locks will not retract, consult factory authorized personnel.

DO NOT OVERRIDE ANY SAFETY FEATURE IN AN ATTEMPT TO LOWER THE LIFT.

NOTE: The lock bar will reset automatically when the lift is fully lowered. If during the lowering process the lock bar resets before it gets to the fully lowered position, continue lowering by repeating steps 5 or 6 from above.

MAINTENANCE

To avoid personal injury, permit only qualified personnel to perform maintenance on this equipment. Maintenance personnel should follow lockout/tag out instructions per ANSI Z244.1.

The following maintenance points are suggested as the basis of a routine maintenance program. The actual maintenance program should be tailored to the installation. See ANSI/ALI ALOIM booklet for periodic inspection checklist and maintenance log sheet.

- If lift stops short of full rise or chatters, check fluid level and bleed both cylinders per Installation Instructions.
- Replace all Safety, Warning or Caution Labels if missing or damaged (See Installation instructions page 3.)

See repair parts breakdown for replacement parts.

ALWAYS: Keep all anchor bolts tight. (1/2" Anchors 30 ft-lbs, 3/4" Anchors 80 ft-lbs).

ALWAYS: Keep all pivot bolts tight.

ALWAYS: Keep lift clean. Raise lift when cleaning floor area.

DAILY: Inspect spacer pads for damage or excessive wear.

DAILY: Check lock bar handle and release mechanism for damage or binding.

WEEKLY: Inspect all lift parts for signs of damage due to improper use.


MONTHLY: Lubricate lock bar pivot bolt and lock bar handle pivot points.

MONTHLY: Lubricate all hinge joints if there are signs of rusting.

MONTHLY: Visually inspect concrete floor for cracks and/or spalls within 12" of base plate

SEMI-ANNUALLY: Check fluid level of lift power unit and refill if required. Use only Dexron III ATF or 10wt anti-foam, anti-rust hydraulic oil. If fluid is required, inspect hose and connections and cylinder seals. Repair as required.




